

RELEASE AND WAIVER OF LIABILITY AND INDEMNIFICATION

This Release and Waiver of Liability and Indemnification (the "Release") is hereby executed on the date written below by the undersigned as the parent or legal guardian of the participant, a minor ("MINOR") in favor of the Chinese American Cultural Association of Rockland, Inc., their affiliates, including in each case without limitation, their directors, officers, employees, volunteers, and agents (collectively "CACAR").

The MINOR desires to engage in certain activities and/or events with CACAR, including but not limited to participation in the mixed martial arts program (the "Activities") and I understand that his/her participation in these Activities may include but are not limited to sitting, standing, kicking, bending and any other activities reasonably anticipated to be performed by MINOR as a part of, or in any way associated with CACAR's mixed martial arts program. I acknowledge that he/she derives personal satisfaction and a benefit by virtue of his/ her participation with the CACAR mixed martial arts program and/or performing the Activities described above, and I understand that the MINOR willingly engages in these Activities.

I represent and warrant that I am the parent or legal guardian of the MINOR, with authority to sign this Release on the MINOR's behalf. I hereby freely, voluntarily, and without influence from anyone or duress of any kind execute this Release and consent and agrees to each of the following:

On behalf of the undersigned, MINOR, MINOR's personal representatives, heirs, next of kin, successors and assigns:

ASSUMPTION OF THE RISK: The undersigned understands that the Activities include work that may be hazardous to the MINOR, including but not limited to sitting, standing, kicking, bending and any other activities reasonably anticipated to be performed by the MINOR as a part of, or in any way associated with, RELEASEES' mixed martial arts program, and hereby knowingly assumes the risk of injury, harm and loss associated with the Activities and participation with the RELEASEES' mixed martial arts program, including any injury, harm and loss caused by the negligence, fault or misconduct of any kind on the part of RELEASEES.

RELEASE AND WAIVER OF LIABILITY. THE UNDERSIGNED HERBY WAIVES, RELEASES AND DISCHARGES RELEASEES FROM ANY AND ALL LIABILITY FOR PERSONAL INJURY, DISABILITY, DEATH, PROPERTY DAMAGES, PROPERTY THEFT OR CLAIMS OF ANY NATURE WHICH MAY HEREAFTER ACCRUE TO THE MINOR AS A RESULT OF DIRECT OR INDIRECT PARTICIPATION IN THE RELEASEES' MIXED MARTIAL ARTS PROGRAM.

INDEMNIFICATION. THE UNDERSIGNED AGREES TO DEFEND, INDEMNIFY, AND HOLD HARMLESS THE RELEASEES, FROM AND AGAINST ANY AND ALL CLAIMS OF ANY NATURE INCLUDING, WITHOUT LIMITATION, ALL COSTS, EXPENSES AND ATTORNEYS' FEES, WHICH IN ANY MANNER MAY RESULT FROM MINOR'S PARTICIPATION IN THE MIXED MARTIAL ARTS PROGRAM. INCLUDING, BUT NOT LIMITED TO, ANY PERSONAL INJURIES, LOSSES OR DAMAGES AND/OR PROPERTY DAMAGE AS A RESULT OF THE MINOR'S ACTS OR OMISSIONS UPON THE RELEASEES' OR ANY THIRD-PARTY PREMISES OR PROPERTY ON WHICH THE RELEASEES' MIXED MARTIAL ARTS PROGRAM ACTIVITIES TAKES PLACE.

This Release and Waiver of Liability and Indemnification shall be construed broadly to provide a release and waiver of liability and indemnification to the maximum extent allowed by law.
